Routes as an Alternative: A route could also be configured so that each route stop (representing different assets or locations) populates the Multiple Assets, Locations, and CIs table on a single work order when applied. This allows for sequence control and record management while still using a single main work order. This setup minimizes the need to manage multiple child work orders or complex work order hierarchies, particularly when performing similar tasks on several assets simultaneously.
